principles of cooperation:

Blackburn College (Blackburn, United Kingdom), represented by Chief Executive Officer Ian Clinton, on the one side, and The Association Of Educational Institutions Of Secondary Professional Education of Chelyabinsk region (Chelyabinsk, Russia), represented by the Chairman of the Board of the Association of Educational Establishments Of Secondary Professional Education of Chelyabinsk region Igor Iosifovich Tuber, acting under the Charter, on the other side, hereinafter referred to as the Parties, in accordance with the mutual desire of the nations of Great Britain and Russia to develop educational cooperation as the basis for the preparation of highly qualified personnel for external economic relations of the two countries, with joint priorities in the sphere of education and research, agreed on the following basic

Section 1

The purpose of this Agreement is a cooperation between the Parties in the sphere of educational and research activities, development of exchanging students, PhD students and faculty members.

Section 2

To realize the objectives of this Agreement the Parties agree:

- to promote bilateral exchange of students, undergraduates, postgraduates, doctoral students and faculty members;
- to promote the development of joint educational programs, undergraduate and master's level programs, including "double degree";
 - to promote scientific cooperation and joint research in areas of mutual interest;
- to promote the organization and conduct training to improve the academic qualifications of doctoral students, graduate students, undergraduates and faculty members;
 - to share their experiences of advanced methods of education;
- to organize joint international scientific and practical forums (workshops, seminars and conferences), including those, using remote technologies;
 - to organize and carry out joint educational and research projects.

Section 3

The Parties agree that cooperation will be carried out both in general between them and between their separated structures or specific employees in the form most appropriate for both parties.

Section 4

The parties agree that the educational and scientific cooperation between them will be carried out based on joint projects, which will be signed by representatives of the Parties, after agreement on all terms of cooperation.



Section 5

The Parties will make academic exchanges based on individual invitations and by mutual agreement.

Section 6

This agreement shall enter into force upon signature. The contract can not be changed or added without the mutual agreement of both Parties. All changes and additions must be set out in writing and signed by the Parties.

Section 7

This Agreement is available in two versions: in English and Russian languages, with one copy of each option for the two universities. All copies have equal legal force.
